EXPRESSION OF INTEREST FOR SICILIAN AND MALTESE COMPANIES AVAILABLE TO HOST RECIPIENTS OF CROSS-BORDER MOBILITY VOUCHERS FOR THE IMPLEMENTATION OF INTERNSHIP

The MOVE ON project, funded by the "INTERREG VA Italy Malta 2014-2020 Cross-border Cooperation Program" - Public Notice 2/2019 "targeted call", promotes the employment and competitiveness of the Sicily-Malta area by supporting cross-border mobility paths of young and newly graduated, unemployed or unempoyed, through job placement internships, with the provision of mobility vouchers and related support services.

The Consortium Society Ass.For.SEO arl, as Lead Partner of the "MOVE ON" project, with HERMES Corporation Limited (Malta) Co-beneficiary project partner, has published two Notices for the selection of 100 recipients, 75 residents in Sicily and 25 residents of Malta, of mobility vouchers of the amount of 12,000 euros gross for carrying out internships for work placement lasting six months, to be concluded in any case no later than 30 September 2022.

With this expression of interest, Hermes intends to establish a long list of of Maltese companies and entities suitable and interested in hosting 75 Sicilian recipients of cross-border mobility vouchers selected through a Public Notice.

Those who intend to express their interest in hosting trainees must meet the following requirements:

- Fall within the definition of a company and contained in Art. 1 of Annex 1 of Reg. (EU) no. 651/2014
- have an operational headquarters in Malta
- be operating in the sectors:
 - ✓ Health and quality of life;
 - ✓ Environment protection;
 - ✓ Services for sustainable tourism.

The conduct of the internship will be agreed and formalized in the Agreement stipulated between the provider and the hosting company as well as in the Individual Training Plan.

Adherence to this Expression of Interest will allow the company concerned to join the Italy - Malta cross-border network, with mention on the MOVE ON project site, and to receive all information relating to the project and the related programming developments, in terms of opportunities for collaboration, funding and training.
